



Mill Maintenance General Foreman

- Minimum five to ten years' of related experience in mill maintenance that includes crushers, SAG and ball mills, maintenance planning, and experience in a large mining environment
- Previous experience as a supervisor essential, experience as a general foreman an asset
- Have excellent written and verbal communication skills
