Summary

Reporting to the Environment Manager, the Environmental Technician is responsible for working with the environment team to complete environmental monitoring activities.

This is a temporary full-time role on a 5x2 rotation, 12-hour shifts, day shift.

Responsibilities

- Participates in all Company Environment and Health & Safety programs and supports the safety culture through involvement in daily and monthly safety meetings and initiatives,
- Adheres strictly to personal protective equipment (PPE) requirements in all areas while on mine property,
- Collects and prepares for shipping, water, air, vegetation, and other samples as required by regulations and permits and as directed by the Environmental Coordinator
- Calibrates and performs maintenance on environmental monitoring equipment,

- Maintains detailed records of field monitoring activities, site inspections, sample conditions, and instrument calibrations (e.g., field datasheets, logbook, etc.),
- Updates and maintains environmental monitoring databases and reporting in the Environmental Data Management System,
- Performs monitoring activities according to prescribed procedures, processes, and standards, including quality control protocols to ensure high-quality sample and information collection,
- Participates in planning and monitoring activities related to the reclamation plan and all environmental management plans, such as water management, invasive weed management, surface erosion, and sediment control, and soil and vegetation management,
- Assists with waste management activities,
- Works with the environmental and engineering consultants in conducting on-site field activities related to monitoring and research programs,
- Promotes environmental awareness and standards relating to the environmental policy and environmental management plans,
- Communicates information related to environmental activities and performance to Lower and Upper Similkameen Indian Band Chief's, Council, and community, both verbally and in writing,
- Participates in information meetings with the public, regulatory agencies, and local First Nations,
- Performs any other responsibilities related to the Environmental Technician & Community Liaison role as required or as assigned by the Environmental Manager.

Education & Experience

- High School Diploma or General Educational Development (GED),
- Post-secondary diploma in sciences, with a strong preference for natural resources, environmental sciences, biology, environmental monitoring and planning, or a closely related field is considered an asset,
- Experience in conducting environmental fieldwork is considered an asset,
- Prior work experience with environmental compliance and monitoring in the mining industry is highly considered,
- Experience operating Four Wheel Drive (AWD) vehicles, snowmobiles, and ATV units considered an asset,
- Proficient in Microsoft Office applications (Word, Excel, PowerPoint, Outlook),
- Possess a valid driver's license and have access to personal transportation.

Required Skills

- Strong written, verbal, and interpersonal communication skills with a capability to communicate and present ideas,
- Have high regard for personal safety and the safety of company property and other employees,
- Ability to set up, calibrate, operate, and maintain field equipment,
- Skill in working in a fast-paced, dynamic work environment,
- Ability to perform tasks with minimal supervision,
- Motivated self-starter with the ability to manage multiple priorities simultaneously under tight deadlines,
- Ability to walk several kilometers while carrying sampling equipment,
- Required to meet pre-employment testing requirements.

Working Conditions

- Frequent exposure to various conditions associated with working outdoors, including weather conditions, e.g., rain, snow, heat, cold; hiking, and working in remote locations,
- Work may require the employee to perform repetitive heavy lifting or moving items and equipment up to 50 pounds,
- Work requires manual dexterity to operate and calibrate field equipment, tools, and computer peripherals,

- Work requires operating a light vehicle at our operations, in various weather conditions and terrain, including winter driving.

Other Requirements

- Successful completion of pre-employment screening requirements and drug & alcohol testing,
